## Terms and Conditions for Cash Rebate Privilege for Service Fee Payment on Grab application in Thailand

1. This privilege is for Citigold customer who has maintained an outstanding balance and/or investment of THB 5 million and above.
2. Citibank reserves the right to offer THB150 per month for Citigold customer who has maintained an outstanding balance and/or investment of THB 5 million but less than THB10 million, THB 300 per month for Citigold Preferred customer who has maintained an outstanding balance and/or investment of THB 10 million but less than THB 50 million, and THB 500 per month for Citigold Elite customer who has maintained an outstanding balance and/or investment of THB 50 million, when having the service fee transaction in Grab application in Thailand through Citi Credit Card (primary card).
3. This benefit is for Citigold customer who pays for any service fees on Grab application in Thailand such as Transportations, GrabFood and GrabExpress with Citi Credit Card (primary card).

Citibank will credit the cash rebate at the actual spending amount to the credit card account used for the transaction when spending through Citi Credit Card (primary card) within 60 days after the transaction month. The total of cash rebate will not exceed THB150 per month per customer for Citigold customer, THB 300 per month per customer for Citigold Preferred customer and THB 500 per month per customer for Citigold Elite customer.

In case that the customer has the service fee transaction on Grab application in Thailand through multiple Citi Credit Cards, the cash rebate will be credited only to the customer's credit card account with maximum spending amount in each month.
